# Distance/Blended Learning Rigor: Asynchronous Learning during Blended Learning

Each campus will be implementing a Blended Learning schedule that requires the students who are requesting Blended Learning to be in the building two days per week and distance learning for the remaining three days of the week. Students will have their attendance taken as they traditionally would while they are scheduled to be in the building. The remaining distance learning time will be monitored through the completion of the asynchronous work assigned during the blended learning time. If the student completes the assigned work (or calls the school if they do not complete the work to excuse the absence) the student's attendance will not be negatively affected. A daily call in option may also be added based upon the infrastructure to provide another avenue to be in attendance in school.

# Blended Learning: Drop Off/Pick Up Schedules

Each campus has finalized identifying the remaining needs of their buildings in order to be COVID ready for staff & students. Each campus has built a daily drop off/pick up schedule that aligns with the overall district needs. Cohorts have been built with Cohort A being the "In Town" students and Cohort B being the "Out of Town plus Flat Iron" students. To avoid unnecessary congregating, each campus has a drop off/pick up schedule that will allow buses to drop students off every 5-10 minutes at the identified entrance in the Scenario 2 plans.

## **Attendance Update**

Each campus has identified an Attendance Committee member and they have identified the total number of No Connection students. The No Connection students & families have made zero connection or contact with BPS. The process of dropping these students & referring to Truancy Court will begin on Jan. 19, 2021. The BPS Attendance Committee has finalized a rigorous system & checklist of contacting students & families to make these Connections. BPS Administration will not drop a student or refer to Truancy Court without having completed fully our BPS system of contacting students & families. It is only after this checklist has been exhausted does this process begin. Each campus has also made the distinction between tracking student attendance for packet & iPad students. The total number of students with No Connection has decreased using this system.

#### Instructional Time:


Each campus has completed a detailed minute by minute daily instructional schedule that maximizes the instructional day which is 9am-3pm daily.
