RE: Dismissal of Full-Time Teachers
DATE: April 5, 2012

It has been our practice in past years to dismiss certain certificated, full-time teachers due to the return of teachers from full or partial leave, enrollment uncertainty in specific academic areas, certification deficiencies, or for budget reasons. Taking such action at this time in the school year protects the school district from employing individuals whose services are not required or who will not hold the proper Illinois teaching certification next school year. Taking this action also provides our administrators with greater flexibility in creating a staffing plan that is responsive to changes in student enrollment and/or student course selection patterns.

Later in the school year, when staffing requirements for the 2012-2013 school year are more fully known, we will be in a better position to re-employ these staff members at an appropriate level of service or employ new staff members who can better meet our staffing needs.

I recommend that Board of Education adopt the attached resolution.
