Reasons stated for denial were, "based upon the recommendati	on that would require a one-on-
one paraprofessional in order to be successful in the classroom	

School choice law 2-1.03 "These rules do not require a school district to add teachers, staff, or classrooms, or in any way exceed the requirements and standards established by the existing law." was stated.

If I am correct, law 2-1.03 is referencing adding "teachers, staff, or classrooms" in terms of exceeding capacity, not in terms of making sure that a special needs child is receiving an appropriate education and supervision as an individual with a disability.

I would like to appeal this decision based on law 3-1.05.3 "A school district shall not deny a student the ability to transfer to a nonresident school under these rules unless there is a lack of capacity at the nonresident school."

Furthermore, is very capable of being successful in a classroom without a paraprofessional so long as he is with a certified special education teacher, or teachers aid (adult). Despite struggling to be able to walk alone without the guidance of an adult and with independent toileting (which is usually handled by the school nurse), he is very smart and is above reading level and excels in math.

It is my hope, Commissioner, that you overturn the determination of the nonresident district, and allow both my to attend Harmony Grove, a B rated school, rather than their resident district, a D rated school, together.
