**SUBJECT:** **Region One Purchasing Cooperative Automotive and Bus Parts, Tires, Tubes, Supplies, Equipment and Repairs RFP 16-08-19, Extension 1 of 3**

**BACKGROUND AND SIGNIFICANT ISSUES:** This request for proposal (RFP) allows the Region One Education Service Center, and the Region One Purchasing Cooperative (ROPC) members, the opportunity to contract with qualified vendors for Automotive and Bus Parts, Tires, Tubes, Supplies, Equipment and Repairs on an as-needed basis to procure services that include, but not be limited to drive train parts, electrical parts, batteries, gaskets and seals, steering and suspensions, air conditioning, brakes, transmissions, lights, lenses, mirrors, wipers, tools, belts and hoses, shop supplies, safety equipment, tires and radiators, air conditioning repair, alternator repair, brake repair, engine repair, car repair, fleet repair, cooling system repair, driveline repair, oil changes, suspension repair, tire installation, rotation and balancing, transmission repair, tune-ups, wheel alignment, muffler repair, glass repair, body and paint repairs. Item descriptions, specifications and/or technical requirements and estimated quantities and pricing, and/or price lists and/or catalogs have been provided by each vendor enclosed. ROPC members are required to conduct a cost or price analysis for the procurement of goods and/or services not listed in the items tab, and within the scope of services offered with this bid solicitation. ROPC members are responsible for the selection of goods and/or services available to meet their needs.

On September 28, 2016 the Region One Education Service Center Purchasing Department received thirty-one (31) responses to Automotive and Bus Parts, Tires, Tubes, Supplies, Equipment and Repairs Proposal 16-08-19. On October 18, 2016 the Region One Education Service Center Board of Directors met to review and approve the recommendations of the ROPC Automotive and Bus Parts, Tires, Tubes, Supplies, Equipment and Repairs RFP 16-08-19, effective November 1, 2016 through October 31, 2017, with the option to extend up to three (3) additional one (1) year periods, or through October 31, 2020 if all parties are in agreement. Thirty (30) vendors were recommended for award; one (1) vendor, Nuga Diesel - Brownsville, TX, submitted a “no bid” response and was not awarded.

On behalf of the ROPC membership, the current thirty (30) vendors were offered the opportunity to utilize the first of three (3) one-year extension agreements, twenty-eight (28) vendors agreed to the extension offer, and two (2) vendors: C&H Security Systems Corp. DBA All Valley Key and Lock - Harlingen, TX; and Gerardo Valdez DBA The Auto Glass Guys - Elsa, TX declined the extension offer. The extension agreement is effective November 1, 2017 through October 31, 2018.

**RELATED GOAL:** To assist the ESC and its cooperative members in Region One and other school districts, charter schools, and governmental entities throughout the State operate more efficiently and economically (TEC §8.002).

**COST AND FUNDING SOURCES:** Region One Education Service Center programs and its cooperative members order products and/or services directly through the awarded vendor(s). There is no membership fee charged to the ROPC members to join the Region One Purchasing Cooperative. Of the net total invoice amounts on all services performed under this proposal, a flat fixed service fee rate of \$0.01 cents on each \$1.00 dollar (or 1%) of total sales made through this contract paid to the Region One ESC by the vendors.
