| | As discussed in our charter application, American Quality Schools (AQS), our sponsoring entity and charter holder, was to turn over the charter to a local, 501 (c)(3) non-profit organization which would operate only the Arkansas Military and First Responders Academy charter school. Specifically, it was stated that the aim of AQS was to transfer "the ongoing operation of the school to the original citizen's groups" when that became practicable. We have attached to this amendment request form a copy of the determination letter from the Internal Revenue Service granting 501 (c) (3) non-profit corporation status to Arkansas Military and First Responders Academy, Inc. Therefore, in fulfillment of what we stated during the charter application process, we are requesting an amendment to our charter to substitute Arkansas Military and First Responders Academy, Inc. as the charter school's sponsoring entity and charter holder in place of AQS. This amendment will allow the local group to carry forward the mission of the Arkansas Military and First Responders Academy. AQS is in total support of this charter amendment request. | | | | |

1. Budget projections that include the costs associated with the amendment request and demonstrate that the approval of the request will not place an unduly financial burden on the charter.

The cost of the amendment request is \$0, and as such will not place an undue burden on the school.

2. Current year to date enrollment by race and grade.

AMFRA will open on August 16th with an estimated student body of approximately 140-160 students in Grade 9.
