Districts are responsible for benchmarking their performance against surrounding districts and their respective ratings.

- Out of 28 eligible campuses, 11 (**39%** of campuses) received at least one campus distinction.
- Elementary- 5 out of 16 (**31%**) earned at least one campus distinction.
- Junior High- 1 out of 6 (**16%**) earned at least one campus distinction.
- High School- 5 out of 6 eligible campuses (**83%**) earned at least one campus distinction.
