# **Selma Elementary School**

- The scope of work consists of a new elementary school and associated sitework. The new facility is in the City of Selma.
- Life Safety Systems are being prepared for inspection to include hydronic, and fire alarm protection. Judson network connectivity proceeds as scheduled.
- Site development continues with landscaping and site fencing being installed.
- The general contractor is installing windows and door openings to provide weatherproof spaces for the building envelope.
- Interior finishes, doors, and millwork are being applied throughout the campus.
- Judson has submitted a request for variance from the City of Selma's residential-adjacent perimeter privacy fencing ordinance. Per the City's Unified Development Code (UDC), fencing abutting a residential property line shall obstruct the view of the immediate property owners and shall be made of wood or a masonry product. Texas Administrative Code (TAC) Sec. 82-72 School Safety Requirements does not permit the use of wooden screening because it is considered scalable. Resolution will not be in time for the beginning of school, August 13, 2025. In the meantime, the project management team is examining options to create a security perimeter that encompasses the building and always guaranteeing safety and security, as defined by the TAC.

- Life Safety Systems are being prepared for inspection to include hydronic, elevator, and fire alarm protection. Judson network connectivity proceeds as scheduled. The kitchen cafeteria is being finalized for the health department inspection.
- Site work continues outside of the building. The general contractor is focusing on site construction, that includes the final pour of concrete in the interior courtyard, forming flatwork around the building perimeter, grading driveways/parking lots throughout the site in preparation for the application of asphalt, and applying sod to the baseball and football fields.
- Interior finishes, doors, and millwork are being applied throughout the building.
