ITEMS OF DISCUSSION

Building Reports: Ms. Bremner stated that curriculum and instruction report is very helpful. They do a lot. Glenn Hall talked about the space under the Skpecial Education building; concerned unless the clinic wants to move. They are doing an outstanding service for the school. If they move will consider using as an office. Discussion about the middle school is very exciting. Corrina out for appraisal now and will bring to board when have the information. Planning at tribe is very interested in the possibility of purchasing. Will bring information to board. Jercy grades 6-8. Corrina 7-8. Will have further discussion.

Superintendent's Report

Administrator Recognition: Mary Ellen LaFromboise recognized and honored principals and vice principals in School District 9. Ms. LaFromboise stated that she attended a council meeting in August and was impressed by the energy and vitality of the group. The majority of the principals are from Browning and all are BHS graduates. All have a common vision and a common goal for our children to continue on to be healthy and happy and use all their talents possible. Windy Oldchief performed an honor song in recognition of the Principals. Tonia Tatsey-KW Vina, Jennifer LaFromboise-BES, Jessica Racine-Napi Elementary, Dennis Juneau-BMS, John Salois-BHS.

Presentation on Student Study: Vernon Grant, Zeus Rutherford and Isaac Wippert presented results of an assessment of health behavior patterns and perspectives in Blackfeet Youth in the 6th-8th grade. The research study was conducted last spring based on sedentary activity, sleep, and screen time. Demographics include grade, gender, and body weight. The study results show high number of obesity, low physical activity, lack of sleep. Mr. Grant recommends school bring back recesses as it impacts learning and behavior and health. Issues that kids focused on over and over in the survey: bullying which was the biggest issue, and nothing to do in the community. Mr. Grant will be writing a grant to the national institute of health to bring in an activity such as soccer and asked the district for a letter of support. The grant, if awarded, will pay for coaches, referees, training, equipment such as gear, shoes, shin guards, socks, etc. Board members felt that the opportunity for more student activities in the community will help with obesity, keeping kids out of trouble, give kids more to do than video games and asked Mr. Grant to connect with Tony Wagner. Wayne Hall stated that his extra transportation funds could be used for busing students to attend activities.

Mr. Calica entered meeting.

Fall Student Count 2017-2018: Stacy Edwards reported on the ANB Summary for each school and noted that 2017 spring count was elementary: 1,449 and high school: 550 and the 2017 fall count is elementary: 1,449 and fall: 579, a total 2,028 students for the 2017 fall count.

Review Trustee Financial Statement and Adopted Budget: Stacy Edwards reported that she is still working with Kathleen Warner from OPI to complete both reports.

Mr. Evans stated that the superintendent called the school board and the board agreed by consensus to build the bleachers. Ms. Bremner stated that it does create more accountability to have \$5,000.00 in place. Superintendent Hall stated that most districts are at \$10,000.00. Mr. Evans asked if food and fuel are exempt and can be bought without prior approval. Stacy Edards stated no, anything over \$5,000.00 is approved by the board first and all claims are approved by the school board. No further discussion. Motion carried 5-1 with Mr. Evans opposed.
