Traczyk moved, seconded by Sacks, that the Board of Education move into open session at 4:30 p.m. Roll call vote.

Motion passed.

**Action on Student Discipline**

Barber moved, seconded by Traczyk, that the Board of Education approve the following resolution.

**WHEREAS**, The Board of Education of Oak Park School District 97, Cook County, Illinois, did through the Board on January 12, 2012, hold a hearing concerning possible expulsion of Student No. 20120112, and,

**WHEREAS**, the evidence taken at said hearing shows that Student No. 20120112 has been found guilty of a violation of the rules and regulations of this School District, the Illinois School Code, and the Statutes of the State of Illinois,

**NOW, THEREFORE**, it is hereby resolved that Student No. 20120112 is:

Expelled from attendance at Oak Park School District 97 effective January 13, 2012 and through June 30, 2013. The 2012-13 period of the expulsion may be held in abeyance if the student successfully completes an educational plan as developed by the district by June 30, 2012. The superintendent is authorized to review the student's performance relative to that plan and determine if the abeyance will be upheld. The Student will not be allowed to attend or participate in any District 97 activities, including athletic events, social events, and those events related to end of year activities, and is prohibited from being present on school grounds during this same time period.

**NOW, THEREFORE**, it is hereby further resolved that the Superintendent is to issue a written notice of the Board's decision to the guardian of Student No. 20120112.

It was moved by Barber and seconded by Traczyk that this Resolution, as read, be adopted.

After due consideration thereof, the President put the question and upon roll call being had, the following members present voted:

Motion passed.
