IV-06 Dispatch of Ambulance Policy: Discussion was held regarding the Dispatch of Ambulance Policy.

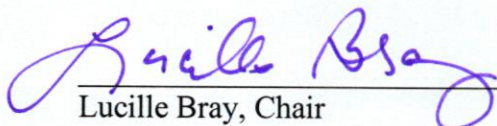
Motion was made by Rory Sherwood with support from Nick Harrison to approve the Dispatch of Ambulance Policy, as amended. Motion carried.

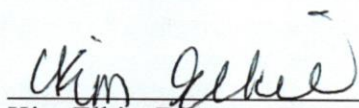
ACTION ITEM #3: The Committee recommends to approve the Dispatch of Ambulance Policy, as amended.
