A. K-5 Literacy / Reading Resource Report and Findings - Kristine Woleck lead off the presentation. The information was a background of Literacy Resources, where we stood as a district, and how we planned to move forward to use resources to meet needs of the community. She described what was focused on during the pilot. Allyson Story went into detail about the pilot of Wit and Wisdom Bookworms along with Teachers College units of study. This pilot started back in September of 2023, and had several phases leading to completion. The findings concluded that Bookworms in all of its content fully met the criteria we were seeking in a new resource. Dr. Woleck then provided a Q&A with the subcommittee regarding professional development needs.

B. New Fairfield HS NEASC Update - James D'Amico presented on our most recent check-in point from 4.29. There was a review of a 5-year progress report. Our Accreditation has been continued.
