Establishing Committee to Address Youth Homeless Needs on the Blackfeet Reservation

No. 458-2021

- WHEREAS, The Blackfeet Tribal Business Council is the duly constituted governing body within the exterior boundaries of the Blackfeet Indian Nation pursuant to Section 16 of Act of June 18, 1934 and Amendments thereof, and
- WHEREAS, The Blackfeet Tribal Business Council has been organized to represent, develop, protect and advance the views, interests, and resources education and resources of the Blackfeet Indian Reservation, and
- WHEREAS, Pursuant to Article VI, Sec. 1 (g) of the Blackfeet Constitution and By-Laws, the Blackfeet Tribal Business Council is empowered to manage tribal affairs in an acceptable and businesslike manner and in accordance with the administrative plan, called the Plan of Operations, and
- WHEREAS, The Blackfeet Reservation has a need to address the need for safe homes for all persons residing on the Blackfeet Reservation to which include an alarming number of homeless youth, and
- WHEREAS, The Blackfeet Tribal Business Council desires to establish a committee to address this need and to dedicate tribal resources towards this effort, now

THEREFORE, BE IT RESOLVED:

- 1. The Blackfeet Tribal Business Council hereby establishes a committee to address homeless needs of the youth on the Blackfeet Reservation, to be appointed by the Council as needed.
- 2. The Committee shall report the findings back to the Blackfeet Tribal Business Council for recommendations to address the purposes of this resolution.
- 3. That the Chairman or Vice-Chairman in the Chairman's absence and Secretary of the Blackfeet Tribal Business Council are hereby authorized to sign this Resolution and any other documents to effectuate the purposes of this Resolution.
