Ref: Vehicles & Equipment

As all of you know, the Sheriff's Office is transitioning from county owned high mileage patrol vehicles to an entirely new fleet of leased vehicles. This process started early 2022 with the order of 8 vehicles and subsequently an additional 6 in 2023. This process has been trying at times and were subjected to a supply chain crisis. When we started this project, it was the goal to equip every vehicle the same and install new incar cameras that were linked to new body cameras. On August 9, 2022, the Alpena County Board of Commissioners approved \$112,000.00 for the purchase of body cameras and 7 in-car cameras. Another \$76,172.32 was approved to outfit the first 8 leased vehicles.


As of now, we have recently received two administration vehicles and outfitted. We anticipate receiving another two vehicles at any time, leaving 4 to be completed. With an additional 6 vehicles on order for later 2023 and to complete this project correctly, we are going to need 5 additional in-car cameras for the remaining 6 vehicles. We are also going to need two MDT's, three in-car printers, 3 routers, 1 radio, and 3 computer mounts.

The cost for 5 in-car cameras and 5 years of data storage is \$57,225.00. The remaining equipment would cost approximately \$15,000. To complete this project and be respective of this year's budget, I'm requesting that we add 5 in-car cameras to our first camera order. If we do this, we can make yearly payments out of the \$112,000 already approved for the next few years and budget for the remaining years that it didn't cover. With the additional equipment purchase, I ask that we be permitted to use a portion of the \$76,172.32 approved outfitting money for those purchases and then use remaining funds towards actual outfitting. Any outfitting costs that we couldn't cover would then be rolled into the existing vehicle lease amount.




