

ORDER AMENDING AN ORDER CALLING A BOND ELECTION; PROVIDING FOR THE CONDUCT AND THE GIVING OF NOTICE OF SAID ELECTION; AND ENACTING OTHER PROVISIONS RELATING TO THE SUBJECT

WHEREAS, the Board of Trustees of Denton Independent School District (the "District") adopted an order (the "Election Order") calling a bond election (the "Bond Election") to be held on November 5, 2013, within the District;

WHEREAS, the Election Order, specifically Exhibit A attached thereto, sets forth the polling places for the Bond Election;

WHEREAS, the District has entered into a joint election contract (the "Contract") with the Denton County Elections Division pursuant to which the Denton County Elections Division is to provide certain services for the conduct of the Bond Election;

WHEREAS, the Denton County Elections Division has provided the District with a revised list of the polling places for the Bond Election; and

WHEREAS, this Board of Trustees hereby finds and determines that the Election Order should be amended to designate and provide for the designation of polling places for the Bond Election; now, therefore

BE IT ORDERED BY THE BOARD OF TRUSTEES OF DENTON INDEPENDENT SCHOOL DISTRICT:

Section 1. Exhibit A to the Election Order is hereby amended to read as set forth on Exhibit A attached hereto.

Section 2. The Superintendent of the District is hereby authorized and directed to approve any changes or corrections to the exhibit attached hereto as may be necessary to reflect any changes to polling locations and times and/or as otherwise designated by the Denton County Elections Division.

Section 3. A substantial copy of the Election Order, as amended herein, shall serve as the notice of election to be posted and published as prescribed by Section 9 of the Election Order and in accordance with law. Posting and publication of the notice of election with the polling places as designated herein is hereby ratified and approved.

Section 4. The Election Order, as amended herein, shall remain in full force and effect.

Section 5. This Order shall be effective immediately from and after its passage.
