Description: No Red Ink is an online platform that provides students with individualized data based on a pre-assessment that assists the teacher in assigning personalized grammar and writing concepts. No Red Ink also provides STAAR support with opportunities to practice with new item types, writing short/extended constructed responses, and newly tested writing TEKS for previously untested grade levels. Teachers are able to monitor student progress and give real time feedback to help drive student success.

Historical Data: This year concludes the final year of the agreement, and we do not intend to renew for 2026–2027.


