

# **Consent Item**

**Subject**: Consider Approval of the Guaranteed Maximum Price for the 2023 Bond First-Sale Hebron High School 20-Year Life Cycle Maintenance and Repair – Phase 2 Project (FB19)

## **Background Information:**

- The Hebron High School 20-Year Life Cycle Maintenance and Repair Phase 2 Project has been assigned to Stantec as the architect at the December 11, 2023, Board Meeting and Joeris General Contractors as the Construction Manager at Risk firm by the Board of Trustees at the May 13, 2024, Board Meeting.
- The Guaranteed Maximum Price (GMP) process was presented to the Board in a Discussion Item at the February 5, 2024, Board Work Session.
- The Hebron High School 20-Year Life Cycle Maintenance and Repair Phase 2 Project has been advertised and competitively bid to sub-contractors by Joeris General Contractors, the Construction Manager at Risk firm. The sub-contractor bids have been evaluated and scoped for this project. Joeris General Contractors has presented a Guaranteed Maximum Price (GMP) for this project.
- Joeris General Contractors has presented a total Guaranteed Maximum Price for the Hebron High School 20-Year Life Cycle Maintenance and Repair – Phase 2 Project of \$27,187,534.
  The pricing is within the overall project budget and presents the best value to the District.
- The GMP includes an allowance for the band practice lot work while Administration continues to work through those design options.

# **Administrative Consideration:**

- Funding for this project is provided from the 2023 Bond Funds.
- The procurement complies with Section 2269 of the Government Code.

#### Recommendations:

- That the Guaranteed Maximum Price of \$27,187,534 for the Hebron High School 20-Year Life Cycle Maintenance and Repair Phase 2 Project by Joeris General Contractors be approved.
- That the Superintendent, Chief Financial Officer, or Executive Director of Procurement and Contracts be authorized to sign any documents to implement this action.

### Timeline/Report:

 Upon approval, sub-contracts will be executed, materials will be ordered, and work will begin during the summer of 2025. This project is estimated to take two summers and one full school year to complete.
