




Students who are selected attend a 2 day trip to the grand canyon, glen canyon dam, wupatki national monument, and sunset crater national park. These places help to solidify the work we do all year in science as articulated by the state science standards. Many students who are selected are on free and/or reduced lunch and cannot afford the cost of the trip. How will students be recruited?	Students identified themselves as interested in attending. All 7th grade teachers rated the interested students on their attitude, effort, behavior and cooperation. The scores were averaged and the top 60 students are the ones initially identified. The remaining students were placed on a <input type="checkbox"/>
What criteria will be used in selecting students for the program?	The students are rated on their attitude, effort, behavior and cooperation. This allows students who are trying hard, but struggle in subjects not to be discounted due to grades.
List your concrete and measurable student enrichment outcomes?	The students will be able to, upon returning, describe the major causes of the formation of the Grand Canyon as well as identify two major earth forms that they saw that were created by Earth's movements.
What are your criteria for assessing each outcome?	The outcomes will be assessed on correct identification as well as scientific accuracy on explaining their identification.
