This is a program that is sponsored by the Texas Agri-Life and the Texas DSHS. 3rd grade students attend this program. There are a number of students and topics discussed.

The date for this year's Safety Day was in the last school week of May 2024.

#### 4. Vaping Education

YouTube videos that were shared with the campus principals at the Jr. High and High Schools. The videos were sent to the teacher for the students to watch during flex classes.

### 5. Internet Safety (Secondary) (Provided by A and M agrilife and Juvenile probation)

Both secondary campuses would like to continue the program in future years.

## 5.0 SHAC Recommendations

- 1. The SHAC members are in agreement that the Dating Dilemmas program should be presented to the 8th grade students. The committee also agrees with the district that parents must sign a permission slip in order for students to be allowed to attend the program. ( A and M Agrilife)
- 2. The SHAC members agree that the water safety program should be continued as long as funding is available.
- 3. The SHAC members agreed that a Vaping Awareness program should be presented to high school and Jr High students during the 25/26 school year.
- 4. The SHAC members agreed we should have the internet safety presentation on a yearly basis at secondary level with parent presentations after school hours. (A and M Agrilife)
- 5. SHAC members agreed that Bellville ISD for human sexuality will not make any changes. Bellville ISD is an abstinence only district. BISD for Biology curriculum will only teach genetics as approved in curriculum (Meiosis and Mitosis). At the elementary level (Grade 5) we will continue with body changing (puberty) video by Proctor and Gamble with required parent approval.
- 6. The committee is still seeking new parent members. HS student has volunteered to serve on committee for the 25/26 school year.
