RESOLUTION AUTHORIZING THE TRANSFER OF MONIES FROM THE EDUCATIONAL FUND TO THE TRANSPORTATION FUND AND TO THE OPERATIONS AND MAINTENANCE FUND- (2025)

WHEREAS, there are presently more than sufficient funds in the District's Educational Fund to meet currently anticipated expenditures for Education purposes; and

WHEREAS, there are insufficient funds in the District's Transportation Fund to meet currently anticipated expenditures in that fund relating to certain transportation expenses; and

WHEREAS, this Board of Education has received reports from the Administration that a total of \$200,000 DOLLARS may be transferred from the District's Educational Fund to the Transportation Fund to meet those expenses of that fund; and

WHEREAS, there are insufficient funds in the District's Operations and Maintenance Fund to meet currently anticipated expenditures in that fund relating to certain operations and maintenance related expenses; and

WHEREAS, this Board of Education has received reports from the Administration that a total of \$650,000 DOLLARS may be transferred from the District's Educational Fund to the Operations and Maintenance Fund to meet those expenses of that fund; and

WHEREAS, a public hearing has been held on this date (i) at least (7) days and not more than (30) days following the publication of a notice in a newspaper of general circulation within the School District and (ii) at least 48 hours following the posting of a notice over the name of the Board Secretary at the principal office of the Board, both such notices setting forth the time, date, place and subject matter of the hearing on the proposed transfers of funds; and

WHEREAS, the proposed transfers of funds are authorized by Section 17-2A of the Illinois School Code under such circumstances;

NOW, THEREFORE, be it resolved by the Board of Education of Harlem School District 122, as follows:

<u>Section 1.</u> This Board of Education finds the preambles of this Resolution to be true and correct and incorporates the same herein.

Section 2. The School Treasurer is hereby directed to_(i) transfer the sum of \$200,000 DOLLARS from the District's Educational Fund to the Transportation Fund on a permanent basis and (ii) transfer the sum of \$650,000 DOLLARS from the District's Educational Fund to the Operations and Maintenance Fund on a permanent basis.

<u>Section 3.</u> The Secretary of this Board of Education is directed to cause to be served upon the School Treasurer a certified copy of this Resolution.

<u>Section 4.</u> This Resolution shall be in full force and effect upon its adoption.
