A motion was made to expel Student #287600494 from Dupo Community Unit School District No. 196 for two years from October 9, 2025, through and including October 8, 2027, based on the Board's determination that the student engaged in egregious conduct and that the student's continued presence at school poses a threat to school safety of other students and staff and substantially disrupts the operation of the school. The Board further finds that given the severity of the student's misconduct, there are no other appropriate disciplinary interventions available and that the presence of the student at school will foster a culture that the student's behavior at school is acceptable or tolerated. The Board further finds that the student's expulsion shall be held in abeyance, and he shall be permitted to enroll in the Regional Office of Education ("ROE") Alternative School. If the student fails to enroll or is denied enrollment in and/or removed from the ROE Alternative School, for any reason, the student shall not be eligible to enroll in the Dupo Community Unit School District, or any other public-school district until they have served the full period of expulsion. The student, during the period of his expulsion, is prohibited from attending or being present at any Dupo Community Unit School District events, whether the event is on or off school property and shall not enter upon any Dupo Community Unit School District property at any time, except with the prior written permission of the Superintendent. The motion was made by Member Stoll and seconded by Member Carroll.
