Subject:

Computer Lab Refresh – Department of Computer Science

Recommendation:

Approve the refresh of equipment in three campus computer labs to adequately support the current and future software needs of the Department

of Computer Science curriculum.

Background and Rationale:

The WCJC Department of Computer Science offers courses in three computer labs across the institution:

- Peace 106 (Wharton): 24 Student Computers; 1 Faculty Computer; Last refresh 2014
- Richmond 141 (Richmond): 24 Student Computers; 1 Faculty Computer; Last refresh 2014
- Brazos Hall 370 (Sugar Land): 24 Student Computers; 1 Faculty Computer; Last refresh 2018

In order to train students in the optimal environment, the Computer Science curriculum must be updated to Windows 11. Due to the age of the machines in each of the above mentioned labs, an upgrade to this new OS is not possible.

A refresh of the equipment in these labs is required in order to support the needs of the curriculum. This refresh will result in the purchase of a total of 75 computers to be installed prior to the start of the Fall 2023 semester. These machines will be capable of running Windows 11 and, when needed, will be available to upgrade to Windows 12.
