TITLE: Approval of Out of State Travel

BACKGROUND:

STUDENTS

Ben Bultman from Amphitheater High School requests permission to take 2 students from Student Council to the AASC Region 6 Student Council Conference in Kansas City, Missouri, June 22-27, 2017. Approximate cost of the travel is \$3,750 and will be paid for by student activity funds and tax credit donations. No school day will be missed.

Amphitheater School District has a strong tradition of participation in contests of academic challenges, including Career and Technical Student Organization's (CTSO) national competitions for FCCLA (Nashville, TN July 2-6), Skills USA (Louisville, KY June 19-25), and HOSA (Orlando, FL June 21-25). As we have done for the last several years, prior approval is granted without names. Specific information will not be known until the CTSO's state competitions that occur in April. Approval now allows our schools to begin fundraising.
