**EXECUTIVE SESSION**: Mr. Busenbark moved and Mr. Bench seconded that the Board go into executive session to discuss personnel, and procurement evaluation at 4:00 p.m; aye votes: Mr. Bench, Mr. Busenbark, Ms. Wells, Mr. Smith, Mr. Thacker. Nay votes: none. Motion passed. Mr. Buenbark moved and Mr. Bench seconded that the Board go out of executive session at 6:00 p.m.; passed unanimously.

**WORK SESSION**: The Board discussed preschool operations and possible FFA projects.

**REGULAR SESSION**: President Smith called the regular session to order at 7:00 p.m. Mr. Bench offered prayer. The Union High Choir sang the National Anthem. Mr. Smith led the Pledge of Allegiance to the Flag of the United States of America.

**RECOGNITION**: The Union High Choir performed for the Board and noted their accomplishments for the past year. Awards were presented to Jacqueline Anderson, Michelle Larsen and Kayden Richens for their exceptional contributions to student and school success.

**ADMINISTRATIVE REPORTS**: The Board reported on visits to East Elementary and Jr. High schools. Dave Green, Principal, reported on UHS goals. Teams meet weekly with multiple efforts to reach a target of ninety percent graduation, and they also collaborate on the values and skills of the District's portrait of a graduate. At-risk students who are struggling are receiving extra attention. They are also targeting 18 for the average ACT test score. Training for student engagement is ongoing.

**OPEN TIME**: At 7:42 p.m. President Smith opened the meeting for those who signed up for public comment. Cliff Murray asked how the District defines mastery for early graduation, and noted Utah Code says parents are primarily responsible for the education of their children. Kimberley Murray works as an induction coach and noted concern for a lot of teachers suffering from second hand trauma and the need for support. President Smith closed open time at 7:49 p.m.
