### Scope of work for Video Surveillance 'Whole System' Upgrade:

- □ Provide and install (1) Avigilon Video Surveillance 48TB server w/ dual power supply.
- \* Server comes with a 3yr warranty. \*
- □ Provide and install (1) IP license for (54) new cameras across the district.
- Provide and install (1) 2MP Outdoor dome camera to (4) outdoor locations.
- □ Provide and install (1) 3MP Outdoor dome camera to (1) outdoor location.
- Provide and install (1) 3MP Indoor/Outdoor bullet camera to (15) camera locations.
- □ Provide and install (1) 3MP Indoor dome camera to (34) indoor locations.
- ☐ Provide labor to program system (User Credentials)
- □ Provide training and IT services to connect system.
- CPS will require (2) IP Addresses for network video surveillance server and (1) IP addresses for (54) IP Cameras.
- \* This server is to replace an End of Life existing video surveillance server that is on-site presently for all district cameras. \*
- \*\* The camera replacement are for (54) cameras that are either End of Life or near End of Life that are presently on-site within the district. \*\*
- ☐ The new Video Surveillance system will integrate with the new Avigilon Access Control that was previously proposed to make one complete system.

- All signatures of work orders and change orders acceptance will constitute acceptance of the outlined scope and confirm and guarantee payment in the amount as shown over and above the original accepted contract/proposal amount.
- All labor is figured at normal prevailing wage rate during normal installation times.
  Weekend installation times requires prevailing wage weekend rates.

- CPS warrants all services for a period of 90 days on labor and 1 year on parts from the date that the work is performed.
