# <u>Superintendent</u>

Dr. Turner commented on the financial situation of the school district saying there will be no new money for CISD from the state for this next budget cycle. During the regular legislative session there was no relief and a special session will take place this spring only if the legislators agree on a solution. Topics that are currently being discussed are:

- 1. Whether or not there is sufficient money in the system for school districts to operate (two adequacy studies are underway)
- 2. End Recapture but only to reduce property taxes...again, no new money to the school district
- 3. Approval of voucher program

Dr. Turner said "Our only glimmer of hope is the lawsuit and I don't even anticipate that a successful outcome will bring enough revenue to the school district. There are no short term solutions anymore." Dr. Turner stated that there were no indications that the state would be able to offer any additional financial assistance because CISD is already above the state average allotment per student. Any new monies would be directed to less wealthy school districts.
