Per State Law, I am contacting each member of the governing bodies of tax units in Taylor County to let you know your rights and opportunities to have input into the election of new board members of the Taylor Central Appraisal District. Each governing body has the right to nominate up to five people to serve on the board. The elected persons will take office on January 1, 2008, and serve for a two-year term. Nominees must live in Taylor County but not necessarily within your taxing jurisdiction. Nominees must have been a resident of Taylor County for the past two years to be eligible to serve. Employees of a tax unit other than an elected official are ineligible to serve as board members.

Current members of the board that are willing to continue service are Mr. David Copeland, Dr. Colleen Durrington, and Carl Roeder. Mr. Harold Nixon, long-time member and chairman of the board, and Leland Robinson have asked not to be re-appointed.

By resolution of your governing body, you may nominate up to five people to serve on the board of directors. The resolution must be returned to me by October 15, 2007. Before November 1, I will prepare a ballot of all nominees in alphabetical order and send it to your governing body. At a meeting of your tax unit, you may cast your votes for the nominee or nominees of your choosing. The voting is expressed by resolution of your tax unit. A sample resolution will be forwarded to you as I list the nominees. Your tax unit is not required to vote, but is entitled.

The resolutions must be returned to me by December 15, 2007. The results will be announced shortly thereafter. Before you nominate someone, be sure they are willing to serve. If they wish to contact me about the duties and responsibilities of a board member, I will be happy to visit with them. If you have any questions about any part of this elections process, please feel free to contact me. I have enclosed a sheet showing voting entitlement of all tax units. To guarantee a position on the board requires that a person receive a minimum of 834 votes.
