Public Hearing on "School FIRST" Rating	The Texas Legislature created the "School FIRST" rating system in 2001 (Senate Bill 218 of the 77 th Legislature) to improve the management of school districts' financial resources. This was in response to Senate Bill 875 of the 76 th Texas Legislature in 1999.

	2002-2003 (based on 2001-2002 data) was the first year the financial health of every school district in Texas was evaluated as part of the new financial accountability system known as Schools FIRST. The system requires school districts to submit financial data, which is used to rate the district according to defined indicators. School districts are required to hold and advertise a public hearing to report their financial accountability rating to parents and taxpayers. Denton ISD has received the Superior Rating since the creation of this system.
	Public Hearing was opened at 6:34 pm for public comment and no one wished to speak and the public hearing was closed at 6:35 pm.

Budget Update	Debbie Monschke, Exec. Director of Budget & Finance reviewed the summary of budget changes for the 2010-2011 school year.
	 With revenue increases, the budget is now \$436,397 in the black instead of the projected \$2.8 million shortfall. The funding includes: A decrease in property taxes by \$704,520. An increase in student enrollment, which helped increase the state funding by \$2.58 million. An allotment of \$1.79 million in federal SHARS funds. This is from School Health and Related Services and provides reimbursement to the district through Medicaid for health-related services for the 2007-08 school year. This is only the second year the district has received any funding from SHARS.

Robertson Road Re-Alignment- DCTA	Rod Reeves, Facilities Coordinator presented information to the Board of Trustees concerning the realignment of Robertson Road adjacent to Fred Moore High School and to illustrate the operational impacts to the District.
