

AGREEMENT  
BETWEEN  
PANA COMMUNITY UNIT SCHOOL DISTRICT #8  
AND  
PANA SACRED HEART SCHOOL

This Agreement is entered into by the Pana Community Unit School District #8 Board of Education, hereinafter referred to as "Pana" and the Pana Sacred Heart School, hereinafter referred to as "Sacred Heart" for the purpose of sharing certain extracurricular activity programs with eligible students from both school districts. The home school district will be Pana Junior High School.

This Agreement will be effective and covers the 2022-2023 and the 2023-2024 school years and indicated sports for those years.

Pana will offer the following extra-curricular activity and open it for participation to eligible students from PANA and SACRED HEART: Junior High Cheerleading.

TERMS AND CONDITIONS

1. The two entities will not charge each other for allowing students from the other school to participate in any extra-curricular activity or for any costs involved in running any program. Total control of each extra-curricular athletic program remains solely with the school offering the program.
2. Students from both schools will follow and abide by the rules and regulation of the home school district offering the extra-curricular activity in which they are participating. (This includes paying of participation fees, athletics fees, purchasing necessary equipment and apparel, etc.) The exception is that each student will be declared academically eligible or ineligible to participate by the school of enrollment.
3. Students who receive recognition of participation through the awarding of a letter will receive that letter from the school of enrollment. The school offering the extra-curricular activity program will provide other awards such as certificates, pins, bars, trophies, plaques, etc.
4. Transportation to the school offering the extra-curricular activity will be the sole responsibility of the students' parents/guardians.
5. The host school will be responsible for providing equipment and compensation of the coaching personnel.

6. Each participating school will abide by their own existing Board of Education policies regarding school and student insurance and general liabilities. Except as otherwise provided herein, Sacred Heart shall defend, indemnify and hold the Pana CUSD #8 and its Board of Education harmless of and from any all losses, liabilities, damages, injuries, claims, demands, costs and expenses of every kind and every nature, whether or not covered by insurance, including legal fees and defense costs, arising out of or relating in any way to the this Agreement and any extensions or renewals thereof brought by a Sacred Heart student or parent.
7. The host school will provide and maintain appropriate facilities and equipment as outlined through IESA policy.

NOTICE OF NON-RENEWAL OF THIS CONTRACT SHALL BE GIVEN BY APRIL 1, 2024, or upon serving thirty (30) days written notice at any time.
