**RESOLUTION OF THE BOARD OF TRUSTEES
OF MARBLE FALLS INDEPENDENT SCHOOL DISTRICT**

URGING RELEASE OF FEDERAL FUNDS TO PUBLIC SCHOOL DISTRICTS

WHEREAS, the Board of Trustees of Marble Falls Independent School District (the “District”) is committed to providing high-quality educational opportunities, safe environments, and essential support services to all students; and

WHEREAS, the District previously operated the Texas Afterschool Centers on Education (ACE) program, which served all four District elementary campuses, the middle school, and the high school, providing critical academic support, enrichment, and safe supervision for students beyond the regular school day; and

WHEREAS, the ACE program served approximately 1062 students across six campuses in the District, keeping students safe, improving academic progress, and supporting the community’s families by providing reliable and affordable afterschool care; and

WHEREAS, the recent hold on the release of federal funds has resulted in the District losing funding for the ACE program, directly causing the termination of at least fifteen (15) full-time employees whose services were vital to students and families; and

WHEREAS, the loss of the ACE program places significant hardship on students who lose academic and enrichment opportunities, and on parents and guardians who must now secure and pay for alternate afterschool care with little notice, creating both financial and logistical burdens; and

WHEREAS, federal funds including Title I, Title II, Title III, and Title IV are crucial for supporting public school districts in delivering equitable educational services, improving student achievement, and ensuring the safety and well-being of students;

NOW, THEREFORE, BE IT RESOLVED that the Board of Trustees of Marble Falls Independent School District respectfully urges:

- President Donald J. Trump;
- United States Senator Ted Cruz;
- United States Senator John Cornyn;
- United States Representative John Carter;
- all relevant federal departments and agencies; and
- the legislative and executive branches of the United States Government

to immediately release the federal funds being withheld from public school districts, including but not limited to Title I, Title II, Title III, and Title IV funding, so that the District and others across Texas may restore and sustain programs critical to the academic success, safety, and well-being of students and families.

BE IT FURTHER RESOLVED that the Superintendent is directed to transmit this Resolution to the aforementioned officials and to take any other appropriate actions necessary to advocate for the prompt release of these vital funds.
