RESOLUTION RELATING TO GENERAL OBLIGATION TAX ABATEMENT BONDS, SERIES 2013A PURSUANT TO MINNESOTA STATUTES, SECTIONS 469.1812 THROUGH 469.181, AS AMENDED, AND CHAPTER 475; CALLING FOR A PUBLIC HEARING THEREON PURSUANT TO SECTION 147(f) OF THE INTERNAL REVENUE CODE OF 1986, AS AMENDED

BE IT RESOLVED by the School Board (the Board) of Independent School District No. 831 (Forest Lake Area Schools), Minnesota (the School District) as follows:

Section 1. <u>Recitals</u>.

1.1 The District intends to acquire the ice arena and field house known as the Lichtscheidl Arena and Field House (together, the Facility) from the Forest Lake Area Athletic Association (the Association) in order to provide recreational services to District residents (the Project).

1.2 The District is authorized by Minnesota Statutes, Sections 469.1812 through 469.1815, as amended, and Chapter 475 (collectively, the Act), to issue General Obligation Tax Abatement Bonds, Series 2013A (the Bonds) in order to finance the acquisition of the Facility from the Association.

Section 2. Public Hearing.

2.1 Due to the use of the Facility by the Association, Section 147(f) of the Internal Revenue Code of 1986, as amended, requires that, as a condition to the exemption from federal income taxation of interest on the Bonds, this School Board conduct a public hearing on the proposal to undertake and finance the Project. A public hearing on the proposal to undertake and finance the Project as described above is hereby called and shall be held on May 30, 2013, at 6:00 p.m., at the District offices, 6100 N. 210th St., Forest Lake, Minnesota.

2.2 The Clerk shall cause notice of the public hearing substantially the form attached as <u>Exhibit A</u> hereto to be published in the official newspaper of the District and a newspaper of general circulation in the District at least once not fewer than fourteen (14) nor more than thirty (30) days prior to the date fixed for the public hearing.
