## 4. **NEW BUSINESS**

## 4.1 Approval of the Renewal of the CFSD K-12 Gifted Framework

Dr. Conery presented the renewal of the K-12 Gifted Education Programming Framework for governing board approval. ARS 15-779.02 requires districts to submit the scope and sequence for gifted education programming to the Arizona Department of Education for approval on or before July 1, every five years if no changes were made during the previous five years. This school year is the fifth year since the governing board last approved amendments to the K-5 gifted education programming on July 2, 2009. Minor revisions were made to the framework document to update the information or reflect current practice as a result of external influences and/or requirements. No changes have been made to the continuum of services for gifted education in CFSD.

Dr. Conery sought approval of the renewal of the K-12 Gifted Education Programming Framework to meet the compliance indicators for the 2013-14 Cycle 5 Monitoring of Gifted Education Programs, which are due by December 1, 2013. Dr. Conery indicated that this timeframe also provided the district with ample time for a July 1, 2014, submission to the Arizona Department of Education.

Upon a motion by Ms. Silverberg and a second by Dr. Bergan, the governing board approved the renewal of the K-12 Gifted Education Programming Framework, as presented. Motion carried 5-0.

## 4.2 Approval of Technical Revisions to Policy IKF Graduation Requirements

Dr. Conery presented the technical revisions to Policy IKF Graduation Requirements. Revisions included modifications to reflect the correct name of the social studies courses required for graduation by students at grades 9 and 10. Other modifications included the removal of the list of graduation requirements for the class of 2013, a reorganization of the science and social studies requirements to make the lists easier to read, and the removal of outdated school years that no longer apply to graduation requirements of students.

Ms. Silverberg suggested additional modifications to IKF-RB under the threshold determination to omit the outdated school years that no longer apply to graduation requirements of students and under the eligibility requirements for augmentation to remove a date that no longer applied to students. The governing board agreed that these additional modifications would make the policy easier to read.

Upon a motion by Ms. Jackson and a second by Ms. Siegler, the governing board approved the technical revisions to Policy IKF, IKF-RB, and IKF-EB *Graduation Requirements*, as amended. Motion carried 5-0.

## 5. FUTURE AGENDA CONSIDERATIONS

There were no requests for future agenda considerations.
