#### **ALC Meeting: December 3, 2024**

The District 33 PreK/Elementary Academic Leadership Council met last week. The purpose of the ALC is to advise and make recommendations to the Board of Education on matters concerning curriculum and instruction through the approved decision-making processes. The goal of the ALC this year is Program Coherence. We want to ensure all staff feel there is a clear and consistent plan for curriculum, instruction, and resources in each content area.

Please read through the Talking Points below from our most recent meeting.

- We reviewed the long-range curriculum plan as a reminder of the work scheduled for this year. You can view the <u>Elementary Long Range Curriculum Plan here</u>. This plan includes selecting resources, writing curriculum documents, and reviewing the curriculum for effectiveness. Different subject areas are staggered across the next 4 years, effectuating purposeful improvements, and consistency for curricular resources over several years. We hope this provides clarity to teachers on the timeline for the work that is occurring.
- Subject Area Committee (SAC) work is up and running. Please see an overview of the Subject Area Committee work here.
- Math Fact Fluency Trial- 3 Programs were out for trial, but only 9 staff members responded to the survey. The trial was extended
  for 3 more weeks (end of December). Kate Mayster is modeling/doing the work for Building Fact Fluency. Please let Kate know if
  you are interested in working with her on this.
- The committee received an update on the Amplify Literacy pilot. You can view the presentation that was shared with the ALC and the Board of Education <a href="here">here</a>.
- The committee will meet again in January and provide Talking Points from the meeting.
