The following policies have been updated and presented for the Board's review. The Board reviews policies in two readings: the first to discuss them and make changes as necessary, and the second to finalize any changes and adopt new policies. The following policies are presented for the Board's second reading. There have been no changes to the policies from the first reading which occurred at the January 13, 2026 Special meeting.

The policies have been modified due to changes in the law, legal references, and a review to ensure they are current.

Each policy includes footnotes with backup information on all changes. The recommendation for each policy is listed below.

I recommend the Board approve the policies as presented.

2:120	<b>Board Member Development</b> - Policy was updated for continuous improvement. Removed one extraneous sentence regarding when the dismissal process.	Adopt
2:150	<b>Committees</b> - The two standing committees required by law, the Parent/Teacher Advisory Committee regarding student discipline and the Behavioral Interventions Committee for Students with Disabilities, are now listed in policy 2:150.	Adopt
2:270	<b>Discrimination and Harassment on the Basis of Race, Color, and National Origin Prohibited</b> - Minor grammatical edits were incorporated. Updated for continuous improvement.	Adopt
4:10	<b>Fiscal and Business Management</b> - Updated by law. No later than December 1 each year, a school board must make its statement of affairs available to the public by posting it on the district's website and publishing it in a newspaper of general circulation.	Adopt
4:30	<b>Revenue and Investments</b> - Updated due to law. Updates include rules regarding the deposit of funds the district must follow for investing.	Adopt
4:80	<b>Accounting and Audits</b> - Adds language regarding the requirements for posting the annual financial report. Optional language is not included.	Adopt with edits
4:140	<b>Waiver of Student Fees</b> - Legal references were updated.	Adopt

4:190	<b>Target School Violence Prevention Program</b> - Legal references were updated.	Adopt
5:10	<b>Equal Employment Opportunity and Minority Recruitment</b> - Updated language to include “the use of District issued equipment to record such types of violence” as required by law.	Adopt
5:90	<b>Abused and Neglected Child Reporting</b> - Updated language to coincide with law.	Adopt
5:100	<b>Staff Development Program</b> - Updated citations and renumbered by law.	Adopt
5:190	<b>Teacher Qualifications</b> - Updated legal references.	Adopt
5:200	<b>Terms and Conditions of Employment and Dismissal</b> - Added language to accommodate nursing mothers as required by law.	Adopt
5:220	<b>Substitute Teachers</b> - Updated legal references and requires districts to provide training and materials regarding emergency drills to substitute teachers.	Adopt
5:280	<b>Duties and Qualifications</b> - Updated language for continuous improvement.	Adopt
5:300	<b>Schedules and Employment Year</b> - Updated language to ensure nursing mothers are compensated for reasonable time needed to express milk.	Adopt
6:20	<b>School Year Calendar and Day</b> - Updated the law making commemorative holidays optional to observe during the school day. Legal references were updated.	Adopt
6:60	<p><b>Curriculum Content</b> - Removed the following mandates:</p> <ul style="list-style-type: none"> <li>• Drug and substance abuse prevention</li> <li>• Character education</li> <li>• Voting process</li> <li>• Dangers of fentanyl</li> <li>• Viewing of Congressional Medal of Honor Film</li> </ul> <p>Added the following mandates:</p> <ul style="list-style-type: none"> <li>• Internet/online safety</li> <li>• Rewording health education and safety mandates</li> </ul> <p>Updated legal references.</p>	Adopt
6:130	<b>Enrichment Program</b> - Policy was written by the Board’s attorney to maintain the enrichment program while complying with school code.	Maintain current policy
6:160	<b>English Learners</b> - Changed heading of “Parent Involvement” to “Parent/Guardian Involvement”	Adopt
6:220	<b>Bring Your Own Technology (BYOT) Program; Responsible Use and Conduct</b> - Legal references were updated.	Adopt
6:260	<b>Complaints About Curriculum, Instructional Materials, and Programs</b> - Legal references updated to include a recent court case.	Adopt
6:280	<b>Review and Monitoring - Grading and Promotion</b> - Periodic review of policy. No changes recommended.	Adopt
6:315	<b>High School Credit for Students in Grade 7 or 8</b> - Legal references updated.	Adopt
7:10	<b>Equal Educational Opportunities</b> - Legal references updated to comply with new laws.	Adopt
7:150	<b>Agency and Law Enforcement Requests</b> - The policy was rewritten based on new law requiring districts to establish a policy regarding agency and law enforcement requests at schools. The procedural standards are also incorporated into the policy at the discretion of the Board.	Adopt

7:70	<b>Attendance and Truancy</b> - Updated due to law. Requires approval process for students to attend allowable activities starting in 2026-2027. Examples include instruction in a college level course, participation in youth apprenticeship, and work-based learning environment	Adopt
7:180	<b>Prevention of and Response to Bullying, Intimidation, and Harassment</b> - Update includes language regarding artificial intelligence, posting or distributing explicit images, cyberbullying, and digital replicas.	Adopt
7:190	<b>Student Behavior</b> - Updated to include new language due to law, including procedures if a firearm is brought to school.	Adopt
7:290	<b>Suicide and Depression Awareness and Prevention</b> - Updated due to law and to include information on the back of student id cards (name of contacts in the district and help lines.)	Adopt
7:310	<b>Restrictions on Publications; Elementary Schools</b> - Legal references were updated.	Adopt
7:340	<b>Student Records</b> - Words were revised to match the text of the Illinois School Students Records Act.	Adopt
8:30	<b>Visitors to and Conduct on School Property</b> - Updated words for continuous improvement.	Adopt
