## TEACHER CONTRACT FOR MINNESOTA PUBLIC SCHOOL DISTRICTS

The School Board of Independent School District No. 2143 of the State of Minnesota, Waterville-Elysian- Morristown, Minnesota enters into this agreement, pursuant to M.S. 125.12 as amended, with **Robert Ross**, a legally qualified and licensed teacher who agrees to teach in the public schools of said district as **Physical Education/Health/DAPE Teacher** for the school year, 2021 to 2022.

The following provisions shall apply and are a part of this contract:

- 1. **Basic Services**: Said teacher shall faithfully perform the services prescribed by the school board or its designated representative, whether or not such services are specifically described in this contract, abide by the rules and regulations as established by the school board and State Board of Education, and any additions or amendments thereto, for the annual salary indicated below, and agrees to teach for the school district as assigned in such grades or subjects for which the teacher has the necessary license.
- 2. **Duration**: This contract is subject to the provisions of M.S. 125.12 as amended and to all rules and regulations of the State of Minnesota relevant to qualification, licensure, employment, termination and discharge for cause of teachers. Thereafter, this contract shall remain in full force and effect except if modified by mutual consent of the school board and the teacher or unless terminated as provided by law, or by written resignation pursuant to M.S. 125.12
- 3. **Duty Year**: The teacher's duty year and vacation days shall be as adopted by the school board, and the teacher agrees to teach on those legal holidays on which the school board is authorized to conduct school if the school board so determines. In the event a duty day is lost due to any emergency, the teacher agrees to perform duties on such other day in lieu thereof as determined by the school board.
- 4. Additional Services: The school board, or its designated representative, may assign the teacher to extra curricular, co-curricular, or other assignments, subject to established compensation for such services which exceed the services authorized in paragraph 1. Said extra curricular, co-curricular, or other assignments may be described in paragraph 6 of this contract or by letter of assignment, together with a recitation of the compensation, if any, to be paid for said assignment. The school board or its designated representative, may make any additions or amendments during the duty year as shall be necessary. Said extra curricular, co-curricular, or other compensation, if any, for such assignment shall not become a part of the teacher's Continuing Contract rights unless the words "continuing contract" are recorded immediately following the assignment.
