The District is seeking a single MEP Engineer to design and conduct Project management for the following Bond 2025 Projects:

- 1) Visual & Performing Arts Academic Center
- 2) High School Additions & Renovations
- 3) Career & Technical (CTE) Additions & Renovations

The committee met June 9th and narrowed down the initial field of 10 MEP Engineers for projects #1-#3. And decided that either an MEP role was minimal or not required for projects #4- #6.
