Professional Learning Communities (PLC) is an ongoing process in which educators work collaboratively in recurring cycles of collective inquiry and action research to achieve better results for the students they serve. Professional learning communities operate under the assumption that the key to improved learning for students is continuous job-embedded learning for educators. A team of teachers and admin from every elementary school have been attending trainings from Ms. Keating in Eugene, Oregon. They have shared this new knowledge with school staff, building capacity for continued learning. TRSD staff who attend this trip will learn about the underlying research and resources that support PLCs from a school and district perspective. They will be equipped with tools and resources to further the PLC work in Three Rivers School District.
