### **Early Childhood:**

Registration Update as of November 19th:

We have 65 students registered for Early Childhood Classes:

We have made some minor adjustments to our second semester calendar to make better use of our early out days.

- April 15th screenings during the ½ day of school.

## **Community Education Updates:**

- Adult Enrichment Classes:
  - "Brushes at the Bridge with Community Ed" was held on Thursday, November 6th at the Bridge Tavern with Lakes Area Custom. 24 people attended and the larger venue was much more appropriate for hosting this activity.
  - We have another one coming up on Thursday, December 11th and already have 10 people registered!
- Fall Play: "Three Little Pigs" with Storybook Theatre
  - 33 youth from the area participated. Feedback survey initial results attached.
  - We received a \$2,000 grant from CLEF to offset the cost and keep registration fee low.
  - A revenue-expense report for this event is attached. We completed the event with a net revenue surplus of \$761.00.
  - o The next play is "Little Mermaid" March 23rd-28th. Registration will open January 5th.
- Due to continuing construction and event conflicts our first Community Movie Night will be Friday, January 16th at 6:30pm.
- Advisory Council met November 5th (notes attached). The next meeting is January 5, 2026 at 4:30pm.





Music was louder than the kids were talking.


It was great

More comfortable acting


This year's play was directed by Storybook Theatre. How would you describe your experience with this theatre company?

The overall production was more engaging and the storyline was easier to follow.


