DATE: March 13, 2012

On February 16, 2012, Governor Quinn announced that the state was making available \$50 million for the School Maintenance Grant Program. The dollar-for-dollar state matching grant program provides up to \$50,000 in matching funds for the maintenance or upkeep of buildings or structures for educational purposes. Application materials for the School Maintenance Project Grants became available on March 1, 2012. Applications must be submitted to the Regional Offices of Education by May 1, 2012. As part of the application process, the local Board of Education **MUST** authorize the school maintenance project application during a duly convened meeting **BEFORE** the application can be submitted on IWAS.

The \$50,000 is only per district, not per project. Attached is the grant application for review at our meeting on March 13, 2012. This would return to the Board for formal approval at their April 10, 2012 meeting, and it then can be submitted on April 11, 2012.
