This resource was developed to help learners transform information into learning that deepens meaning and relevance and prepares students for the licensure exam. Within the online lab modules are multiple activities that will allow for collaboration, inspire deeper cognitive thinking, provide support for multiple learning styles, and reinforce the need to know foundational information.

 After completing Levels 1 and 2 of the introduction courses, students will then choose if they want to partake in the Cosmetology Program or the Esthetician
 Program for Levels 3 and 4.
- Esthetician Level 3 and 4 Specialty: 15*
- Cosmetology I Level 3 (Grade 11): 41
- Cosmetology II Level 4 (Grade 12): 31

*This is the first year the Esthetician Program will be available for the students.



Background

24-25 SY

- Milady Cima Curriculum (Cengage)
- In 24-25 SY digital access cost per student was \$125
- Confusion with Curriculum Resources:
 - Milady offered two separate books which would cause confusion with our students since Chapter 5 in Book A was not the same content as Chapter 5 in Book B.
- Milady only provides educational background, whereas
 Pivot Point provides educational background and real
 world experience for the students

Information / Highlights

Improvement Proposal

- TDLR uses PSI, a third party vendor, for testing that is in alignment with Pivot Point booklets.
- Pivot Point cost is less due to digital access rates for grade levels.
- Many resources are provided through the online LAB.
- Both Cosmetology teachers at SSAHS will receive a class set to streamline the program.
 - With access to the same materials, teachers can deliver consistent lessons while incorporating different strategies based on student needs.
 - This approach not only fosters a more cohesive classroom environment but also ensures that all students can engage with the content in a way that resonates with them, promoting a deeper understanding and retention of the material.

Key Points

- Pivot Point digital access cost per student is \$99.
