UNITED SUPERMARKETS, L.L.C., Applicant, applied for a Beer Retailer's Off Premise License, for UNITED SUPERMARKET #534, to be located at 1601 Tennessee Street, Dalhart, Hartley County, Texas 79022 and the mailing address is P. O. Box 6840 Lubbock, Texas 79493.

1. The Applicant applied for a Beer Retailer's Off Premise License under Chapter 71 of the Texas Alcoholic Beverage Code (Code).
2. A protest was filed by the Dalhart ISD Board of Trustees and concerned Citizens of Hartley County. The Protestants based the protest on the place and manner that the applicant may conduct its business warrants the refusal of the license based on the general welfare, peace, morals, safety and sense of decency of the people.
3. Applicant has withdrawn the Application by letter signed by the Applicant on March 28, 2011.


**IT IS THEREFORE ORDERED** that Respondent's APPLICATION for a license is **WITHDRAWN**.
