Tournament fee for Class III is ~~\$420~~ \$440 per Friday through Sunday use and includes all permitted areas. Sanitation service is an additional charge as are any additional custodial needs.

One-day tournament fee is ~~\$210~~ \$220. All other applications will be determined at time of request. Varsity field use must be approved by Director of Student Activities.

For IV and V, a \$500 tournament deposit is required a month in advance.

On-site technician charge is ~~\$50~~/ \$55 hr

Additional costs for custodial, technical, food service, and supervision support will be assessed based using the prevailing hourly rate for the amount of time services are required. There also may be additional costs for trash removal, air-conditioning, and snow removal.

The facility use permit will provide an estimate of costs. Following the event, an invoice detailing actual costs will be provided to the user group.

Refunds for facility use will not be given for the first two weather cancellations.

Payment Due Dates and Late Fees

Payment is due 15 days from receipt of invoice. A ~~\$15~~ \$20 late fee will be charged for unpaid invoices of ~~30~~ 45 days. An additional ~~\$25~~ \$30 late fee will be charged for unpaid invoices of 60 days. After 60 days, the user and the organization will be restricted from facility use and additional late fees will accrue until balance is paid in full.
