#### **5. Elect Budget Committee Chair**

Alesha Anderson made the motion for the Winston-Dillard Budget Board of Directors to nominate Margie Giusto as Budget Board Chair. Bob Shigley seconded the motion and all approved.

#### **6. Elect Budget Committee Vice Chair**

Margie Giusto made the motion for the Winston-Dillard School District Budget Board of Directors nominate Alesha Anderson as Budget Board Vice Chair. Treva Hunter seconded the motion and all approved.

#### **7. Presentation of Budget Message**

Mr. Kevin Wilson, Superintendent read the budget message. The budget reflects the efforts to balance expenditures and projected revenue while addressing the educational needs of our students. A balanced budget is required by Oregon State law for the first budget meeting the adoption process to be completed by June 30, 2025. The March 3, 2025 revenue forecast for fiscal biennium (2025-2027) State School Fund indicates around a \$11.4 billion estimate. Mr. Wilson is recommending a conservative approach to the new fiscal biennium. At state and federal levels, enrollment is on the decline but Winston-Dillard School District is holding strong. The district will prepare for declining enrollment in order to best support our students, staff and community.

#### **8. Discussion of Funds**

Kim Shigley, Business Manager provided each budget board committee member a binder with the proposed budget, summary and supporting documents. Mrs. Shigley reviewed budget account descriptions in the Proposed Budget 2025-26 and provided information on how to walk through the budget documents. Mrs. Shigley shared the district and certified union did bargain at 5% COLA and a 4% on insurance. The district is in the beginning stages of bargaining with the classified union. As employees resign and/or retire, the district is electing to shift staff members between buildings to help meet the current student needs. For the 2025-26 school

year the district is budgeting for class sizes of 20 in the K-3rd classrooms. Mrs. Shigley gave a brief overview of the needed changes in each funding category. Mrs. Treva Hunter enquired about making the pathway from the gym down to the track at the Winston Middle School ADA compliant. The state is looking at funding for all public facilities which includes schools. The district will seek guidance from Shelby Beard, Facilities Director. In the meantime, the district could look at equipment that could help assist students and community members when the need arises. Mr. Stookey wanted to bring to the districts attention the upcoming cost to service the solar panels on the new high school. He was under the impression it needed to be done every 10 years. Mr. Wilson urged the committee to be cautious, strategic and understanding of the budget but most importantly to the needs of our students. Mrs. Shigley reminded the budget board that if they had any questions, she would be happy to sit down with them.
