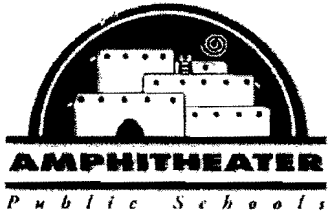
SUBJECT: 2014 Graduation Fireworks Display
