Development of a vertically and horizontally aligned Secondary Art Curriculum grounded in Design Thinking, formatted in Understanding by Design (UbD), focused in College/Career Readiness. This action creates a bridge between a Tier One Research University, and a public K-12 school district by forming a Professional Learning Community involving faculty from both entities.
