KidKare will be open to everyone for the summer and will use the 1:9 ratio and a fee is charged. District Nurses have been updating them every week. Targeted Services will be offered through Distance Learning. Staff have been hired and technology devices can be provided. Opening Doors is providing online opportunities for BINGO, etc.
