The Board of Education of Community Unit School District Number 304 met in a regular session on Monday, April 24, 2017, at 7:00 p.m. at the Coultrap Educational Services Center, 227 North Fourth Street, Geneva, Illinois

The meeting was called to order at 7:00 p.m. by President Grosso.

# 2. BOARD OF EDUCATION REORGANIZATION – President Mark Grosso

2.1 Accept Kane County Clerk's Abstract of Votes for the April 4, 2017, Election of Members for the Board of Education

The Abstract of Votes reported that votes for members of the Board of Education for Geneva Community Unit School District 304 were are follows: Leslie Juby, 4391; Mark Grosso, 4297; Taylor Egan, 4506; Dave Lamb, 3885; Bill Wilson, 3374.

Motion by McCormick, second by Nowak, to approve the above-listed abstract of votes for the April 4, 2017 election of members of the Board of Education, item 2.1. On roll call, Ayes, seven (7), Juby, Lamb, McCormick, Nowak, Stith, Wilson, Grosso. Nays, none (0). Absent, none (0). Abstained, none (0). Motion carried unanimously.

# 2.2 Oath of Office and Seating of New Board Members

Vice-President Nowak asked Bill Wilson to administer the Oath of Office to newly elected members Egan, Grosso, Juby and Lamb. Following the oath, the newly elected members were welcomed and took their places at the Board table.

#### 2.3 Election of Officers

Current Vice President Nowak served as the president pro tempore until the Board elected a permanent president

The president pro tempore explained the process for nominations and voting. Any member can make a nomination, including self-nominations. Nominations do not require a second. Election of an officer requires a majority of those voting. Voting occurs during an open meeting and must not be by secret ballot. Voting can be by a show of hands, or a voice vote in which each member has an opportunity to vote "yes" or "no" for the nominated candidate. If two or more members are nominated for an office, the member receiving a majority of the votes cast is elected.

For the office of president, Juby nominated Grosso. There were no other nominations. Second by Lamb. Grosso was unanimously elected to serve as president and assumed the position and continued the election process for the remaining offices of the board.

For the office of vice president, Lamb nominated Nowak. There were no other nominations. Second by Stith. On roll call, Ayes, seven (7), Egan, Juby, Lamb, McCormick, Nowak, Stith, Grosso. Nays, none (0). Nowak was unanimously elected to serve as vice president.

The President noted that traditionally, the Superintendent has served as Secretary to the Board and the Assistant Superintendent of Business Services has served as Treasurer.

For the office of secretary, Stith nominated Superintendent Mutchler. There were no other nominations. On roll call, Ayes, seven (7), Egan, Juby, Lamb, McCormick, Nowak, Stith, Grosso. Nays, none (0). Superintendent Mutchler was unanimously elected to serve as the board secretary.

For the office of treasurer, McCormick nominated Assistant Superintendent Oberg. There were no other nominations. On roll call, Ayes, seven (7), Egan, Juby, Lamb, McCormick, Nowak, Stith, Grosso. Nays, none (0). Assistant Superintendent Oberg was unanimously elected to serve as treasurer.

4.2 Elementary STEM & Vision Progress Student Presentation

Donna Potazcek, Brigid Buckman and Jill Marsh presented to the Board elementary STEM & Vision progress. Ms. Potazcek had students demonstrate for the Board a math strategy called a Tape Diagram, which is a problem-solving tool that bridges the gap between concrete and abstract thinking. Once the students demonstrated how they were able to solve the problem, they asked Board members to participate in solving a problem using a tape diagram.

Ms. Buchman shared that teachers received professional development on video newsletters so that they could teach their students this process. Students demonstrated to the Board how they create video newsletters collaboratively. The students shared that it can get tricky at times but when you see the final product you would never know.

Ms. Marsh shared that students have been adamant about their love for Mystery Science. Each Board member was given the tools needed to create a sundial. Board members were given instructions how to create their sundials, and once complete, students asked them questions they had to determine the answers to.

4.3 Sodexo Food Service Presentation – Rick Herwaldt (Policy 8500)

Sodexo's General Manager shared with the Board what has been happening in the world of food service. In 2016-17, Sodexo was able to increase individual servings of entrees, fresh fruits and vegetables daily; provide an offering bar with at least four fresh vegetables and one fresh fruit at lunch, continue and improve products with lower fat, whole grains and less sodium; promotions focused on healthy eating; and baked chips. Sodexo is continually looking for ways to reduce carbon footprint and support the health of our environment through their "Better Tomorrow" Plan. They continue to improve customer service and staff safety, as well as, collaborate with the community through food donations, serving the Geneva school community, overseeing fund raising activities that are food service related, and collaborating with community organizations such as Geneva Mothers Club and Geneva Lions Club.

New this year was the opportunity to work with the On the Job Training Program, offer internships and hire high school students to help market the food service program. Also new this year, is Captured which is an innovative approach to gathering student feedback. There have been several activities throughout the school year such as the A to Z Garden Bar, beach parties, cookouts and more! Sodexo continues to communicate with parents and students through newsletters, menus and surveys. Our employees immerse themselves into the Geneva 304 culture every day through their involvement and commitment to the district!

Community members shared their 20-year journey into the story of the "Malvina Hoffman Project." It was accomplished 20 years ago through the Geneva High School Art Department with the help of students who did an independent study of Malvina Hoffman's sculptures, "Races of Mankind", in collaboration with the Chicago Field Museum. Students created an art project from what they had learned from studying Malvina's work, which was displayed at the GHS Arts Affair on May 1, 1997. In September 2016, the GHS National Honor Society decided to re-discover Malvina's work. After visiting the new exhibit at the Field Museum "Re-Thinking Malvina Hoffman" students did a mobile and seven paintings depicting what they learned. The entire project now hangs proudly and permanently in the GHS Library. On April 24, 2017, Louise Grissinger, Mary Lu O'Halloran, and Sammi Branshaw will be speaking before the Geneva 304 School Board about the entire project.

A former Geneva special education student shared with the Board his support of the GSSA. During his 14 years in Geneva, he had the opportunity to work with many aides, and they are the hardest working individuals he knows who should receive equal pay to teachers. They work with so many students with so many different needs. His brother, who has Down's syndrome, has done tremendous in his journey so far with the assistance of aides. Aides do just as much as teachers, and many of the students they work with require more help because of their needs.

The Vice President of the GSSA, also a paraprofessional for 9 years in Geneva, spoke on behalf of her members, sharing that Geneva is an inclusive school district that prides itself on this. It cannot be denied, that a big component of Geneva's success at being inclusive is being a paraprofessional. Our students have a variety of developmental, mental and emotional special needs, however, we have one name for our students, we call them "friends". Paraprofessionals do not have a work area. You may find us sitting at a large table, in a team center, in the hallways, the library, the nurse's office or a variety of other locations to help to assist the many needs of our "friends". We get to know our "friends" on a personal level to understand their day-to-day needs and what works and does not work for them. In addition to our duties for our "friends", we also have updated sub plans to prepare, professional goals and weekly meetings with members of the team. We have helped many of our "friends" step out of their comfort zones. It is because of paraprofessionals that Geneva has been a success as an inclusion school.
