Minutes of the May 18, 2009 Regular School Board Meeting

The Board of Trustees of the Coppell Independent School District, #057-922, met in a regular session on May 18, 2009 at 5:58 p.m. in the Board Room of the Vonita White Administration Building. The meeting was called to order by President Cindy Warner.

NEW BUSINESS

Vice President Ratliff read the Order Canvassing Bond Election Returns (attached).

<u>Proposition No. 1</u> – The issuance of \$40,900,000 of bonds for construction, renovation, improvement, rehabilitation, acquisition and equipment of school buildings in the district, including the purchase of new school buses, and the purchase of the necessary sites for school buildings and levying the tax in payment thereof, including the costs of any credit agreements executed in connection with the bonds

Vice President Ratliff declared that the results of the bond election determine that both Proposition No. 1 and Proposition No. 2 received a favorable majority vote and have carried.

Anthony Hill made a motion to pass the Order Canvassing Bond Election Returns. Bennett Ratliff seconded the motion. The motion carried 6-0.

President Warner presented the results of the May 9, 2008 school board election (attached). (Both incumbents were unopposed in the election.)

President Cindy Warner conducted the election of Board Officers.

Bennett Ratliff made a motion to elect Cindy Warner to the office of President to the Board of Trustees. David Apple seconded the motion. The motion carried 6-0.

Anthony Hill made a motion to elect Bennett Ratliff to the office of Vice-President of the Board of Trustees. David Apple seconded the motion. The motion carried 6-0.

Thom Hulme made a motion to elect Susie Kemp to the office of Secretary of the Board of Trustees. David Apple seconded the motion. The motion carried 6-0.

Cindy Warner made a motion to appoint Kay Ryon as Assistant Secretary to the Board. Susie Kemp seconded the motion. The motion carried 6-0.
