AGENDA ITEM: Consider Approval of Purchase of Flooring Materials for Aledo Middle

School

BACKGROUND INFORMATION:

- Per Board Policy CH (Local), any single, budgeted purchase of goods or services that costs \$50,000 or more, regardless of whether the goods or services are competitively purchased, shall require Board approval before a transaction may take place.
- As you are aware, renovations/additions to Aledo Middle School (AMS) were included within the District's 2019 Bond Program.
- As we have shared with you previously, there are rooms/areas of the current twostory portion of Aledo Middle School that are not being "touched" by the 2019 bond program.
- In an effort to also "touch" these areas, district staff have contacted a painting contractor and flooring contractor to determine the cost of bringing these rooms/areas up to the same standard we have established for the rest of the AMS campus project.
- The attached quote from Floor Partners provides for the removal, disposal, and replacement of the existing flooring surfaces in these areas with the same carpet and luxury vinyl tile (LVT) being installed in the rest of the AMS campus. The quoted cost received from the painting contractor to paint these areas is below the threshold that needs Board of Trustee approval (approximately \$30,000.00).
- Due to the lead time needed for receipt of the flooring products to be installed this summer, we are presenting this item to the Board of Trustees for consideration/action at this time.
- To ensure best pricing and value, the District utilized the Sourcewell purchasing cooperative to obtain pricing from Floor Partners.

FISCAL INFORMATION:

The \$58,960.00 cost of this flooring materials purchase, removal, and installation will be paid from General Fund 199, Function 51.
