Fleet Maintenance Continued...

Our Fleet Manager, Jerry Peterson, is exploring converting one of our vacant school bus driver positions into a hybrid role that combines both sub-driving and vehicle maintenance duties. At present, we are gathering data on school bus mechanic salaries and the necessary equipment for the role. The job description has already been developed.

Routing & Planning Division

At a previous board meeting, we were asked to explore the option of temporarily using an external company to provide drivers until we can fill our current vacancies. Last week, we met with First Student to discuss this possibility, and here is a summary of the meeting.

- **Scope:** We would be outsourcing 3-4 drivers no buses.
- Cost: First Student currently charges \$400 per driver, per day
- **Driver Hours:** The minimum hours is 5 hours per day (per CBA)
- Non-Compete Clause: A non-compete clause would have to be in place.
- **Fingerprinting:** We have the option for them to redo the fingerprints of any assigned drivers.
- Contract Terms: We would agree on a specific contract length (they are willing to work with us on the length). They can start as soon as January.
- **Driver Consistency:** They will make an effort to assign the same driver every day. If a driver is absent, First Student will attempt to cover the absence with available personnel.
- **Safety Meetings/Training:** Their drivers can attend our Safety Meetings/Training, but we would be responsible for paying them during this time.
- They will send us a contract template to review.

Safety & Training Unit

The Safety & Training Supervisor position is still open. We currently have a driver, a former educator, undergoing training to become a school bus driver trainer. He is shadowing our current trainer as part of his preparation.
