1. Provide a DETAILED RATIONALE explaining how the waiver will enhance student learning opportunities, promote innovation, or increase equitable access to effective teachers. Include information about the problem or obstacle, if any, the waiver will help the district overcome.

The school start date for the 2024-2025 school year is currently Monday, August 19. The Clinton School District asks for consideration and approval for the start date to be changed to an earlier date which would afford the district the same equity afforded the charter schools listed above.

The waiver being requested would allow our district to set our school district's first day of classes to begin no earlier than Monday, August 12.

The current law has resulted in a major variation in the allowable opening date of the school year. The earliest being August 14 for the 2023-2024 school year. The last possible opening date of the school year is August 20 for the 2029-2030 school year. If granted, the waiver will enable Clinton School District to open the 2024-2025 school year and the years to follow on the same relative date to this year.

Advantages of the waiver requested:

- With an earlier start to the school year, students and teachers will gain more instructional time and
  minutes to enable them the opportunity to learn the state academic standards and cover other
  curricula. The increased instructional time will enable students to increase student achievement on
  state exams such as ATLAS, ELPA, AP, etc.
- With the school year beginning the week of August 12, the school district will be able to complete
  the first semester before the December holiday break. This fact enables students to take semester
  ending exams before the break rather than taking the exams after a two week period of no
  instruction.
- With beginning the school year earlier, the result will be more teacher-student interaction and
  instructional days before state mandated assessments are given. The increased number of days of
  instruction equates to an increase in student growth to be reflected in all informal and formal
  assessments.

 With the earlier start date, the district calendar could assure the school year ending in the month of May rather than being extended into the summer month of June. The result will enable our teachers to provide increased high quality instruction to Clinton School District students resulting in the learning of skills and strategies needed before assessments. Clinton School District teachers will have the needed time to effectively teach students resulting in less job related stress because of decreased instructional time.

The Clinton School District would like for our students to be given the same opportunities for learning as students in other districts. Receiving the waiver would permit the Clinton School District to maximize student achievement by overcoming the earlier mentioned barriers of starting school on August 19, 2024.

2. Provide a detailed explanation of how the services being waived will be provided for students.

All Clinton School District services would continue without interruption if the waiver is granted. With a beginning school date of August 12, the Clinton School district will be enabled to provide all services in an earlier part of the calendar year. The waiver will allow the school district the opportunity to meet our student and teachers needs in an earlier fashion.

3. Provide a detailed explanation of how the district will monitor and evaluate the effectiveness of the waiver.

The Clinton School District will monitor and evaluate the effectiveness of the waiver by:

- Performing surveys with all stakeholders (staff, parents, and the community)
- Attendance data
- Assessment data (ATLAS, ELPA, AP, interim assessments, etc.)
- CWT data

## Resolution

In Support of a Waiver Request Affecting the Allowable First Day of School A.C.A 6-10-106

**WHEREAS** Arkansas law, A.C.A 6-10-106, provides for the school year to begin no earlier than the Monday of the week containing August 19; and

WHEREAS under this law, A.C.A 6-10-106, the start of school varies from year to year, beginning some years as early as August 14, or as late as August 20; and

WHEREAS under this law, A.C.A 6-10-106, the earliest school can begin is August 19; and

WHEREAS a late start to the school year creates unbalanced semesters, reduces the preparation time for state testing, and limits flexibility in scheduling inclement weather make-up days;

**THEREFORE** be it resolved that the Clinton Board of Education endorses the Superintendent's waiver request affecting the allowable first day of school on August 12, and recommends its approval by the Arkansas State Board of Education.




